- Releasing Community Plan Update draft in January then start EIR will take at least 6 months. We will set up public meetings.

SUPERVISOR'S REPORT-

- The speed limit on South Bay Blvd. has been reduced from 55 m.p.h to 50 m.p.h. . A no parking zone has been established on the east side of Pine Street. • We've been pushing Fish and Wildlife to Service to get going on Habit Conservation Plan. • Hoping to see Progress on Basin Management Plan early next year. • Working on ongoing County water concerns. • Tuesday was last meeting of 2014. • New Supervisors swearing in on January 5th.

We will decide on a fee or 218 vote. Money not used on Waste Water Project will lower budget. • Not going to speculate on Basin Plan until Plan comes out.

- 2 new directors: Lou Tornatzky, Chuck Cesena. • Water Rate Study protest hearing February 5th rate increase 15% 1st year, 15% 2nd year, 8% each of the next 2 years. The study is on the CSD website.
