 Responses
- Put park development in Community Plan, set goal of where, how. Consider long term maintenance, park facilities dependent on development fees. Think of creative financing through residences and philanthropic organizations. Waste water money can only be used for that project. Construction not finished, pipes are in the ground but everything not complete expected completion in July. Construction on pump stations ongoing. Treatment plant towards end of 2015, laterals during 2016. Basin Plan are best calculations we have. We will see how basin responds. Goal of conservation is 50 gal. per person a day (indoor use). If not all conservation money spent on on-going education will seek amended permit to rebate money to project. County sent notices via postcard and in water bills. Waste Water Project paying for crew to protect snails.
